Regular Electronic Meeting Tuesday, October 18, 2022

<u>CALL to ORDER</u>: The Regular Electronic Meeting of Stonewall Democrats of Dallas was held on Tuesday, October 18, 2022, in an electronic format via Zoom. President Todd Hill in the chair called the meeting to order at 6:31 PM CDT. Secretary Omar Jimenez was present.

FUNDRAISING COMMITTEE: The Committee Chair Elissa Wev announced the details of the upcoming Spirit of Stonewall Event on December 5, 2022.

MOTION: Secretary Omar Jimenez moved to approve the Chair and the Executive Board to spend up to \$5,000.00 in campaign contributions for candidates running in the November 8, 2022, General Election. The motion was **not adopted** or **adopted**.

AMENDMENT: Chair Elissa Wev moved to amend the motion to authorize the chair to spend up to \$500.00. The motion was **adopted**.

<u>VOTER REGISTRATION COMMITTEE</u>: Co-Committee Chair Martin Sanez reported that the committee held a Voter Education Town Hall and a Voter Ambassador training with the Texas Democratic Party (TDP).

VOLUNTEERS COMMITTEE: Committee Chair Corey Carrasco announced upcoming candidate block walks.

MEMBERSHIP COMMITTEE: Committee Chair Jay Havran went over the current membership numbers. Chair Havran is working on a membership survey to be sent out to members.

COMMUNICATIONS COMMITTEE: Committee Chair Natalya Efros went over Social Media Statistics of all organizational Social Media Platforms.
