Legislation like Executive Order 11246 first signed by LBJ and then amended by President Obama adding sexual orientation and gender identity to the bill prohibiting discrimination allows us as Americans to draw closer to that more perfect union. When elected, how will you recruit, retain, and create an inclusive environment for LGBTQ and LGBTQ-friendly staff?

Dallas County is an equal opportunity employer. I want my office in particular to be inclusive and representative of all communities. My vision is for the Dallas County Clerk's Office to be the most inclusive, customer service orientated and innovative Department in Dallas County. Once I swear into office, I will meet with all of my employees and conduct surveys, also take a look at how my

offices are constructed and see our areas of opportunities and access information to see if we have the representation of all communities in offices. If we don't, I am proposing task force to solve problems in the Clerk's Office and fulfill the customer service positions when we do away with the automated phone system. This way we can ensure representation is in our office and at the table and not just hidden in a policy.

Would you be willing to appoint a liaison to meet with the LGBTQ community on an ongoing basis? If not, why?

Yes, I envision this as a part of my community outreach board I will implement in my office. I will have a board of people coming together and doing outreach and creating solutions for problems we can solve in various communities. My plan is to have an appointed liaison that represents the LGBTQ community along with other representatives working together to create solutions and support causes in various groups and communities.

Will you have a non-discrimination policy for employment and protection of LGBTQ residents and protection based on sexual orientation or gender identity? If not, why?

Yes, Dallas County policy prohibits discrimination against individuals regarding their race, color, creed, gender, or sexual orientation. Our goals are for everyone who encounters our County Clerk's Office feels served and enjoys their experience. We will review the current Dallas County policy, review it as it pertains to this question, speak with LGBTQ groups and our liaison to ensure the policy is updated or make a more innovative policy to adapt in our office.

How would you handle a situation in which you or a subordinate felt the need to not fulfill all the lawful work duties due to "deeply held religious beliefs"?

We want to protect the rights of all employees and allow them to observe their religious practices. Adaptive Leadership is required in these situations so the Clerk's Office will not fall short in any type of ways. The situation would need to be reviewed and discussed with the employee, administration, and management team. Depending on the nature of the "lawful work duty" and the "deeply held religious belief" we would probably have to seek

the opinion of Civil DAs about solution to these issues in order to resolve the situation.

County Commissioner Candidates

In light of decreased federal and state funding, how would you lead or support funding for HIV prevention in Dallas County including access to PrEP?

In Dallas County we have Health and Human Service HIV grants division. I would be willing to meet with them and support any additional funding for HIV prevention in Dallas. Also continue to support the advocates for HIV prevention, and testing. I would educate myself on PrEP, and ask professionals in HHS how we can help spread the message as a government entity.

What would you do to support and assist the many people with mental illness who must rely on the public system for care in or out of incarceration?

I would support the actions and strides the professionals, the city, and county are making to correct these issues. This being an important community issue must be brought to light so people can become more informed about it. I don't see information like this on Dallas County Clerks website, or social media accounts. The best way is to support initiative and post informative information that support the causes of mental illness and inform the public of the issues surrounding life for mental illness patients and the people who care for them.

How would you address the issues of non-Dallas County Residents using Parkland?

Access to medical care is a top priority in the United States of America and Dallas County. Parkland hospital because of their rules accept patients who may not have insurance or quality insurance. We obviously want this hospital available to Dallas County residence, but to save a life if you have an extra bed a question of where you live is not relevant. If we have the space, and the resources, we can be the leader and example for a nation devastated by this Pandemic.

How would you rate the County's Response to COVID?

First, I want to say regarding the times of crisis we all have endured as Americans and more specifically Texans during these last two years have tested us in ways unimaginable. Both national crisis like the novel Covid-19 Pandemic, and state crisis like the historic power outages last winter forced us to examine our leadership as constituents, and from a leadership perspective crisis provides a unique opportunity for true leadership to unfold when we need it the most.

Emergencies and crisis for leadership are opportunities to respond. Dallas County had to respond like all counties to the only pandemic most of us have seen in our lifetimes. I like the Counties effort to get the information out and try and keep communities safe. As long as we stay informed, continue to improve and keep large testing sites available we can improve our COVID Response each time.

In your opinion, what needed to happen in the past redistricting cycle?

Fair maps to ensure people may feel represented and also have a chance to have their voices heard is what should happen. We don't need gerrymandered maps to be drawn because we want to have power over people, or loop people out. We want fair maps that can get people representation to champion the needs of their communities.

How can the county play a part in expanding voting rights and access, including voting centers and extended hours?

Continuing the spread of information about voters right and access at the polls will help. Posting this information in heavily traffic areas in public and online will certain help this as well. Including voting centers and extended hours is something we can continue to push for and ultimately, I will be the voice or support system where I'm needed. I'm willing to speak out and advocate from my position about these issues. I have done work to register voters CO-Founding the 2020 "Pull up and Vote" event in East Dallas encouraging people to come register to vote, gain information and meet elected officials.

Justice of the Peace Candidates

As many people faced evictions during the COVID pandemic, how would you or did you ensure that the process is fair and compassionate for people facing it?

Well during the pandemic, being the lead of the NAACP Legal Redress Team partnered with the Dallas County Eviction Advocacy Center, Justice of the Peace Sasha Moreno and Mike Jones and other resources to bring the community expert advice and eviction resources both for the tenant and landlord. This forum aloud for guest to come in and ask question directly to judges who rule on cases as well as offered them free legal advice from attorneys and free representative from attorneys dealing with Eviction.

If applicable to your office, how would you address the recent passage of H.B. 25 regarding Transgender Student Athletes ability to participate based on their gender assigned at birth.

It is unacceptable and discriminatory. As Texas's next Comptroller, I will publicly advocate and support the LGBTQ community, including transgender student-athletes ability to participate in the sport they identify.

If applicable to your office, how would you address S.B. 8, the state's Abortion Bill, including private citizen's ability to report anyone involved in supporting report?

I will advocate and publicly support the elimination of this law. It is unbelievable that instead of moving forward, we go backwards. These restrictions are a huge mistake; unsafe abortions will rise, and it's no secret that most take place in un-sanitized, unsafe settings and without the proper counseling. Women's physical and mental health will be at risk and inevitably deteriorate, creating a state crisis.

What specific ideas do you have and/or what current legislation would you support to improve our state economy and address the income inequality and growing poverty rate in Texas, especially as respects recovery from COVID19?

As a Comptroller, I will boost the Texas Economy and Jobs Creation. To do that, here is my proposal:

- Support the increase the minimum wage to \$15 ASAP, \$20.00 p/h by 2030, and \$25.00 p/h by 2035.
- Establish a special incentive for businesses that hire veterans, military spouses, the LGTBQ community, and people with disabilities.
- Legalize recreational marijuana
- Maximize the infrastructure opportunities: (Be proactive and diligent in enhancing, re-building, and expanding roads, bridges, and buildings. Improve transportation capabilities.)
- Incentivize first-time homeowners, first 3-5 years tax break.
- Get rid of / Eradicate corporate tax loopholes.

For small business owners & entrepreneurs

- Reduce taxes for small businesses.

- Design and provide training, tools, and resources to small businesses to boost growth.

Establish alliances with non-profit organizations like local Chambers of Commerce, local Universities that focus on improving their economic empowerment and development of the district.

- Rural Texas: (Assign a 250 million dollars grant program to give farmers the opportunity to establish or expand their businesses.)
- LGTBQ owned businesses initiative: (Assign a 500 million dollars grant program to the LGTBQ community with an entrepreneurial vision that wants to start or expand their business ventures.)
- Woman-owned business initiative: (I support establishing a 500 million dollar grant program for women with an entrepreneurial vision that wants to start or expand their business ventures.)
- Establish a 5-year tax exemption plan for new women-owned business ventures.

If applicable to your office, how would you lead or support efforts to provide better funding for health care and better health care options for all Texas residents?

We need to protect and improve the Affordable Care Act; I believe and support Medicare for All.

- I believe that proper nutrition improves the chances of longer life and reduces the risk of diseases; for that reason, I support more and better education on nutrition.
- I support funding for research on Heart diseases, Cancer, Alzheimer's, Diabetes, and Autism.
- We need to regulate and reduce the cost of prescriptions.
- Medical treatments can't be a luxury, much less a bankruptcy path, we need to establish legislation to prevent the skyrocketing costs of treatments.
- I believe in canceling the enrollment period and maintaining enrollment open all year

Hold accountable big pharmaceutical companies, executives.

- Mental Healthcare: Make available effective prevention treatments, and recovery services available to all.

- I support increasing investments in video health/telehealth

If applicable to your office, what specific ideas do you have to overhaul the Texas Power Grid?

Gov. Abbott has failed again in our Texas communities. We need to solve the power grid issues immediately. I support the use and assignment from the Rainy Day Fund available to attend and support families still impacted by the 2021 winter storm.

It is time to move forward, be proactive, and take care of our environment.

I support Zero-carbon pollution:

- all government buildings by 2040
- all new residential and commercial buildings by 2040
- all new passenger vehicles, trucks, and buses by 2035
- all new passenger vehicles, trucks, and buses by 2045
- Build a massive national network of electronic vehicle supercharger stations.
- Invest and maximize our renewable energy capabilities
- Stop offshore drilling
- Protect our environment, community, state parks, lakes, and beaches
- Protect the ocean's habitat
- Expand marine protected areas
- Establish a nationwide recycling initiative

If applicable to your office, how would you lead or support legislation restoring previous funding for HIV prevention in Texas including access to PrEP?

As Comptroller I will lead the organization with transparency. I have the opportunity to present recommendations on how the Texas budget can be effectively used. I strongly believe that this needs to be a priority.

If applicable to your office, how would you lead or support legislation addressing reparative/conversion therapy in Texas?

This is a dangerous practice, I strongly support banning any reparative/conversion therapy everywhere.

If applicable to your office, what are your ideas for immigration reform in the state level?

I believe that it is crucial to create a new immigration reform with common-sense solutions, recognizing that many people, for years, came to this nation looking for new beginnings, opportunities and to work hard.

I strongly support establishing a path to citizenship for the hardworking individuals that have been in the country for years. Reduce in half the cost of citizenship applications fees. Eliminate 100% of the fee for application for those that asked for asylum and humanitarian protection. Grant asylum and humanitarian protections to those that came from countries with dictators.

What could the state do to improve COVID19 reponse and to prepare for the next pandemic?

We need to start giving every Texan access to high-quality health care, for that reason I believe in Medicare for all, increasing the provider capacity across the state, ensuring federal funding is correctly allocated and using them as assigned. Keep workers on payroll and use the rainy day fund to support working families impacted by the pandemic. Place an immediate moratorium on evictions and foreclosures. Make the covid vaccine mandatory in government facilities and schools.

Preparing for future pandemics, I believe that we need to expand the community health care centers, expand unemployment insurance and build an emergency shelter. We should increase the rainy day fund to 25 billion & allocate \$1.75 to \$2billion annually. The primary purpose of these funds should be for natural

disasters and recession, to support our communities, support people keeping their homes, adequately fund our schools, support any healthcare crisis, provide food assistance and guarantee public safety.

Would you lead or support legislation to require mandatory sexual harassment and Equal Employment Opportunity training similar to the resolution passed in the U.S. Senate that requires Senators, staff, and interns to complete that training each session and submit certification to be published online that their office' fulfilled the requirements?

I was trained as a journalist in the 1970's (won a number of awards writing for the Texas Observer), went to the LBJ School of Public Affairs (UT-Austin) in the 1980's, then to Law School. I have been a practicing attorney since 1992. I have become increasingly appalled at what passes for public policy every two years at the Texas Legislature and in between by our Statewide elected officials. If we can't find a new way of relating to each other, I'm not sure our future will be of any real value to our children.

One of the first studies that I have participated in since this Campaign started is understanding that when we redistrict, we need to have compact districts. Texans have long demanded that their counties be compact. From before the Republic to modern times, counties were constitutionally required to be between 700 and 900 square miles so farmers could travel to the county seat

and back again in one day to properly exercise their franchise. Texas congressional, senate and house districts in 2011, and in 2021, were developed through a hidden process where we had no clue where the sausage came from, let alone how it was made. If we make healthy compact electoral districts, that will go a long way towards better public policy.

In addition, I will commit to on-going studies of our Texas budget process, and program evaluations, so that people can begin to see our government becoming transparent and worthy of our trust. The new Comptroller should revamp the 12 Regions currently used into Regions that make sense. There is no explanation why Comptroller Hegar uses the current Regions. New Regions should be developed so information from the Comptroller's office can be utilized to build communities that are healthy, rather than to enrich those that are already wealthy.

I have been involved in Democratic politics since the early 1980s, in both statewide races and local politics. I was elected to a 6-year term as an Austin Community College Trustee in 2008. I ran for Comptroller in 2018, and ran a novel social media campaign, where I came within 4 percentage points of prevailing in the Democratic Primary. I have maintained my interest in State politics, and before I filed to run this year, I testified before the House Redistricting Committee and told them that "as this Redistricting effort unfolds, I have little doubt that the redistricting effort will be about domination with the intention to create more "zig-zag" districts. Of little concern will be how much this pre-ordained process may hurt Texans. Instead of dividing a county into like six different senatorial districts, or 6 different federal representative electoral districts, as has been done in Texas, we could have districts that enhance communities of interest in a more compact geographic fashion. Compact communities might elect leaders who will work together to heal the vestiges of unfair domination that have plagued Texas for hundreds of years."

Once you are elected, what are some of your plans specific to your office's responsibilities?

The Number One problem is not so much our failure to develop

a fair process for compact congressional, senate, house, and educational districts, it's our failure to develop on-going regional relationships that would foster a fair process for redistricting. That's the way that I hope to run my campaign, by building on providing tools for regional collaborations, taking that to the general elections in November, then continuing that effort after the elections for a new sense of regional collaborations rather than regional divisiveness. By turning civil conversations into civil combat, we can't see how that has made our public programs benefit those with the financial resources to dominate the rest of us. And for those that are able to dominate the rest of us, they can't see how that is a losing sum game when they end up with no markets to ensure their continued wealth.

For almost all of State government, there is almost nowhere to go, but up. Yes, I plan to streamline the office, and use technology to serve citizens more quickly, efficiently and effectively. As for the communication with constituents, if I'm elected it will be in part because I find a way to empower citizen collaborations to get me elected. Then I'm sure that I would continue that effort when elected.

We need to understand that the Texas Comptroller is the largest public data center in Texas, and as such, should begin to produce this information in a form that enhances every region in Texas. If we understand that there is more power in collaboration than in division, we can begin to build a Texas government that belongs to all Texans.

Like Texas counties, which are constitutionally compact, we should have a Redistricting Commission process that ensures compact congressional, house, senate and educational districts. This is essential for producing healthy governmental institutions in Austin.

Texas should have an educational system that is affordable, accessible, and transparent to all Texas children and adults, and this can be done by making clear the monies that are spent for education, and the quality of that education.

Texas should have an economy that is open to all citizens, and for the benefit of all Texans, utilizing the data that is the Texas

Texas officials have played a game of hide and seek regarding tax revenues and the adequate funding of state government for decades,

especially including public schools. We need to break out of the secret codes and share information with our fellow Texans. It is not by accident that citizens access to healthcare, education, and social services has diminished over the years. Making some sort of division between local and State taxes, when they are all paid for by Texas residents, is the worst of mean-spirited tricks. I would attempt to have less of a guessing game regarding State income certification during legislative sessions, and begin to build a matrix of what part of the Texas population has the real tax burden.

If applicable to your office, how would you lead or support efforts to provide better funding for health care and better health care options for all Texas residents?

Especially in this time of the pandemic, it seems particularly obvious that if everyone had access to adequate healthcare, we would all be healthier. We are just figuring out that regarding the world's access to healthcare, it is the areas that have the least access to vaccines that have been the source of the new variants. I just don't understand why people would want to make other people's health the consequence of competition; if you or your children can't afford medicine, then tough. On a practical and ethical basis, we should all have access to good healthcare. Everyone should have access to healthcare, and I imagine that there would be a budget study regarding that and related issues.

If applicable to your office, what specific ideas do you have to overhaul the Texas Power Grid?

We could also have a study about the State of Texas' failure to ensure access to all Texans of a predictable, safe, and reliable power generation system. We could be funding solar generation on peoples' homes as a part of our new generation planning. We should stop acting like the proverbial animal with its head in the fossil fuel oil patch, and get ready for the new world order. This is not rocket science, and I believe that this kind of message will sell in every region in Texas. The people who vote, the people at the bottom, now have enough experience to know that the current Texas Power Grid is not something that is sustainable or for them.

If applicable to your office, how would you lead or support legislation

restoring previous funding for HIV prevention in Texas including access to PrEP?

I believe that this would be part of another study regarding access to healthcare where numbers would not lie.

If applicable to your office, how would you lead or support legislation addressing reparative/conversion therapy in Texas?

I don't know that it would be applicable to the office, except as part of healthcare analysis. As someone who has worked with therapists professionally and personally, one of the other areas that I think is important is what kind of therapy are we going to be utilizing for getting children of the pandemic back in school, back in their normal socialization development. I think that this might well be a good time to get the different healing professions to come together, and vision what it might look like for health and psychological therapies to be advocated for children, not only now, but for lifetime mental and physical health. I think that it could be sold to parents if introduced properly.

If applicable to your office, what are your ideas for immigration reform in the state level?

*There was a 2006 Study that the Comptroller's office did on the impact of undocumented immigrants in Texas that found that they provided more in tax revenue than they cost the State of Texas (may have been less true for local governments). Comptroller Hegar said when he was first running for office 8 years ago that he thought that the study should be updated, but it never was. In 2017, SB 764 was considered by the Texas Senate Committee on Finance, another effort at getting an update on the 2006 analysis, but it too did not pass. I think that the 2006 by Republican Comptroller Susan Combs should be updated.

What could the state do to improve COVID19 reponse and to prepare for the next pandemic?

Universal healthcare and getting vaccines out to all regions of the world so we don't have new variants that develop (like in India and South Africa) because the populations do not have access to vaccines. Maybe even defeat the Republicans in November, but those anti-vac populations will still exist, but we need to defeat

them with community love. I don't know how it will manifest, but we have to come to terms with it. Almost everyone has family members who are part of the anti-vac syndrome, so it needs to be handled with firm kid gloves.

Would you lead or support legislation to require mandatory sexual harassment and Equal Employment Opportunity training similar to the resolution passed in the U.S. Senate that requires Senators, staff, and interns to complete that training each session and submit certification to be published online that their office' fulfilled the requirements?

Yes.

What are your ideas to respond to evidence of climate change?

We are surrounded by the political effects of climate change: mass immigration of dispossessed populations, driven away by war and loss of habitat, and environmental degradation. I believe that in order to really get climate change under control, we must do it at the local level, reaching out for common ground to like-minded communities everywhere, because it has really been the centralized marketing that has made climate change possible, and those forces do not mind if they have to live in gated communities as the rest of use deal with the climate change wake up calls.

If applicable to your office, how would you address voter suppression in Texas and work to expand access to voting by eligible voters?

I will advocate that our district lines be redrawn in 2023 with the new legislature that is elected on a sustained drive for compact districts, just like our Texas counties have been since before the Texas Republic. Voter suppression is just another example of what comes out of dysfunctional districts. The voter suppression laws should be overturned in 2023. I'm sure that an engaged Comptroller's office can provide factual information about the negative impact voter suppression laws will have had on voter behavior, and that is what it was intended to do. Somehow, we have to negate that impact by not succumbing to the negative reactions that the promoters of voter suppression laws have intended, a cure for a non-existent disease.

In your opinion and applicable to your office, what needed to happen in the past redistricting cycle?

The Comptroller should have utilized research demonstrating that the premises for the secret redistricting plan should have been made public, and that compact districts make for better representation.

Please list some of your qualifications and experiences pertinent to the office you are seeking:

As a certified public accountant, I've spent my adult life auditing, accounting for, administering and investigating state and local governments and their grants, taxes, procurement, spending and reporting. In other words - I understand how the system works and how we could better utilize it to our advantage.

Once you are elected, what are some of your plans specific to your office's responsibilities?

Right now we're overpaying for services that don't offer any real benefits. We're paying \$100M MORE in state taxes to DENY comprehensive mental healthcare. We're letting our property taxes pick up the tab when indigent care becomes crisis care. We need to do better and spend smarter. Plain and simple.

When I look at the numbers, I see HUGE opportunity here in Texas. From healthcare to the environment, to creating jobs and new revenue streams - I'm qualified, care deeply, and ready to put in the work.

Texas needs a new tax revenue stream to reduce property tax, fund education, health (& mental health) care, and public safety. A growing number of states are seeing tax benefits of legalizing marijuana for medicinal and recreational use. If we move now on marijuana legalization, we can enact enabling legislation to fund these and/or other social programs. The key is stipulating what % of tax revenues fund which social program in the enabling legislation. If we wait too long, we may miss our window. The industry is mature enough to have established best practices, which should be incorporated.

Ensuring that public safety receives a portion of the tax revenue stream is important. With the new industry, public safety's focus shifts in regards to marijuana.

We will need a banking mechanism so that the business can operate within a banking system and not rely solely on cash.

Distributing licenses for the new businesses should formally consider which communities have been most harmed by the decades-long marijuana incarceration protocol and the resulting impact of felony marijuana convictions on housing, jobs and families.

I would be proud to receive the endorsement and support of the

I would absolutely be willing to appoint a liaison to meet with the LGBTQ+ community on an ongoing basis. LGBTQ+ community members are an important, and often overlooked, voice in our state. I want to change that.

Will you have a non-discrimination policy for employment and protection of LGBTQ residents and protection based on sexual orientation or gender identity? If not, why?

Yes - absolutely. We are working now on our employment documents and they will absolutely include protections for members of the LGBTQ+ community. We will do the same once I am elected as the next Comptroller of Public Accounts here in Texas.

If applicable to your office, how would you lead or support state legislation and/or constitutional amendments pertaining to: A. LGBTQ Couples adopting and providing foster care?

This is not applicable to my office, but I will be voting for candidates who would lead or support state legislation ensuring that LGBTQ+ couples can adopt children and provide foster care.

B. Supporting the repeal of the sodomy law that was ruled unconstitutional by the U.S. Supreme Court?

This is not applicable to my office, but I will be voting for candidates who would lead or support state legislation ensuring that we repeal the unconstitutional sodomy law.

This is not applicable to my office, but I support a repeal of SB8. It is unconstitutional and harms pregnant people in our state.

What specific ideas do you have and/or what current legislation would you support to improve our state economy and address the income inequality and growing poverty rate in Texas, especially as respects recovery from COVID19?

I support legalizing cannabis and ensuring that the market is safe and regulated. That would create 40,000 new jobs and create \$500M a year in state revenue. We would also save money by not incarcerating people, disproportionately POC, for cannabis offenses. I would advocate that this be a new industry that prioritizes POC who have been disproportionately affected by the current cannabis laws.

I support raising the state minimum wage to at least \$15/hour to ensure that Texans do not have to work more than one job to be above the poverty line.

I want Texas to expand healthcare access to every person here. There are steps we can take now to ensure that more people in Texas have access to affordable, quality healthcare, including vision, dental, and mental healthcare.

If applicable to your office, how would you lead or support efforts to provide better funding for health care and better health care options for all Texas residents?

This is not directly applicable to my office but we must expand the Medicaid income eligibility ceiling for adult Texans from \$2,000 per year to ~\$16,000 a year for 10 cents on the dollar! Expand pregnancy coverage from 2 to 12 months after childbirth to improve the chances that Texan women will live to see their child grow up!

Let's eliminate barriers to health care and implement health education reform in the schools and in the communities! Texans deserve no less!

Covering adult Texans under Medicaid will help save our rural hospitals, too. It costs us 10 cents on the dollar. Why would anyone turn down that offer?

If applicable to your office, what specific ideas do you have to overhaul the Texas Power Grid?

This is not applicable to my office, but we could start by investing in improvements to our power grid instead of spending it on vanity border walls. We also might consider requiring ERCOT board members to live in the State of Texas.

If applicable to your office, how would you lead or support legislation restoring previous funding for HIV prevention in Texas including access to PrEP?

This is not applicable to my office, but we should ensure that every Texan has access to PrEP and contraceptives, as well as science-based sexual health education regardless of one's ability to pay for it.

If applicable to your office, how would you lead or support legislation addressing reparative/conversion therapy in Texas?

It is not applicable to my office, but it conversion therapy for minors should be banned in our state, and universally. It is wildly harmful and horrific

If applicable to your office, what are your ideas for immigration reform in the state level?

It is not applicable to my office, but we must reform our immigration system within the state to protect DREAMers and ensure that we treat immigrants and refugees in a humane and expeditious manner.

What could the state do to improve COVID19 reponse and to prepare for the next pandemic?

We could start by electing more people who believe in science and would act accordingly. We need to advocate for vaccines, boosters, masking and social distancing. We must expand rapid, accurate testing across all areas of the state and impliment a better system of notifications for those who may have exposure to COVID-19.

I cannot vote for that legislation, but would support legislation that required mandatory sexual harassment and EEO trainings. I will implement them on my campaign and in my Office, once elected.

What are your ideas to respond to evidence of climate change?

We need laws that provide for a healthy planet. As a Katrina survivor who's been married to a scientist for almost 30 years, Climate Change is very real and personal to me. We need to green the grid, electrify transportation and clean up existing industries. Together, we can still turn this around - and create good-paying jobs.

Wind turbine service jobs and solar installer jobs are two of the fastest growing jobs in the country. Both only require a high school diploma and pay a living wage of over \$40,000 per year.

If applicable to your office, how would you address voter suppression in Texas and work to expand access to voting by eligible voters?

It is not applicable to my office, but I support legislation that expands the franchise of the vote. I would support same-day voter registration, universal mail-in ballots, and other efforts to expand the vote and making it easier for Texans to vote.

Once you are elected, what are some of your plans specific to your office's responsibilities?

Once elected, my initial priority will be to create a program for Pro-se filers to have access, justice, equality, and due process in civil district courts. The program will be a monthly orientation to provide an overview of the civil litigation process, deadlines, motions, discovery, evidence, and trial. This program will empower every individual with the necessary tools to file a lawsuit in civil district court. This program will give everyone access to the court and help those who cannot afford a private attorney.

Over time, I would like to partner with different groups to hold civil district court seminars and educate the community about the court and available resources. My goal with this program is to alleviate the fear of the civil litigation process and empower the community with knowledge, information, and resources.

My mission as a judge will be to establish a Court that decides cases fairly and impartially, free of political and third-party intimidation; to establish a Court where justice is first; to establish a due process-driven court and establish a court where there is equality for all.

As a judge, I will continue to improve our judicial system by making it more efficient and ensuring justice is always the top priority.

When elected, how will you recruit, retain, and create a friendly environment for LGBTQ and LGBTQ-friendly staff?

After I am elected, all of my staff and non-staff (District Clerk and vendors) will respect everyone including the LGBTQ+ community.

My staff and non-staff assigned will know I have a zero-tolerance for disrespect or discrimination. I will be open to hiring potential staff from the LGBTQ+ community. I desire that my partnership with Stonewall Democrats of Dallas will provide me with the network to communicate to the LGBTQ+ community open positions.

I will work with the District Clerk and vendors to encourage everyone to find ways to ensure that the LGBTQ+ community and under-represented communities are notified of all open positions and encouraged to apply.

I believe that government and private sectors need the voice of all diverse communities including the LGBTQ+ community, as employees and decision-makers, to ensure access, justice, and equality for all.

How would you handle a situation in which you or a subordinate felt the need to not fulfill all the lawful work duties due to “deeply held religious beliefs”?

As a Court of justice and protector of rights, I will have a zero-tolerance policy for discrimination against anyone. I will have a zero-tolerance policy for my staff or subordinate of no disrespect, no hindrance or prevention of justice, and no disregard for the constitution, due process, and the law. The mission of my court will be to give access, justice, and equality to all.

The important policies or procedures that I identified that need improvement is lawsuit filed by Pro-se filers.

Do you have ideas to improve access to the courts and court-related services? Yes. If so, what are they?

As I stated in the above question regarding what are your plans specific to your office's responsibilities, I will create an orientation program for Pro-se filers and I will partner with different ethnic and civic groups to provide civil litigation seminars.

Do you believe the composition of juries adequately and fairly reflects society at large? Why or why not? If not, what can we do to change this?

No, I do not believe the composition of juries adequately and fairly reflects Dallas County's Community. Some voters do not understand the importance of the role as jurors and find excuses not to serve on the jury. As part of my civil litigation seminar with ethnic and civic groups, I will educate on the importance of being a juror and serving on a jury and how it impacts the justice system if the juries do adequately and fairly reflect our community.

Lastly, some attorneys knowingly or unknowingly use biases to pick juries during their trial. As Judge, I will educate attorneys on the importance of having juries composed of and reflecting the community at large. I will allow attorneys or pro-se litigants to challenge peremptory challenges based on race, sex, ethnic group, sexuality, and religion. I will educate attorneys and pro-se litigants on the importance of Baston Challenges as a tool to use during jury selection in ensuring justice.

What is your general judicial philosophy?

My general judicial philosophy is all courts should provide access, justice, and equality for all.
